VISIONCORPS' MISSION IS TO EMPOWER INDIVIDUALS WITH VISION LOSS TO ATTAIN INDEPENDENCE; THE MISSION IS FULFILLED THROUGH THIS EMPLOYMENT PROGRAM FOR INDIVIDUALS TO EARN A LIVING WAGE AND BE FINANCIALLY INDEPENDENT. NATIONALLY, THE UNEMPLOYMENT RATE FOR PEOPLE WHO ARE BLIND IS 70%. BECAUSE OF THIS, VISIONCORPS FIRST CONSIDERS INDIVIDUALS WHO ARE BLIND FOR POSITIONS WHICH THEY ARE ACADEMICALLY OR VOCATIONALLY QUALIFIED TO PERFORM AT THE HIGHEST STANDARDS. NO LESS THAN 75% OF DIRECT LABOR PERFORMED AT VISIONCORPS IS DONE BY EMPLOYEES WHO ARE BLIND. IN ADDITION, VISIONCORPS OFFERS TRAINING TO ENCOURAGE UPWARD MOBILITY AND PROMOTIONAL OPPORTUNITIES FOR ALL EMPLOYEES.

REHABILITATION: STATISTICS SHOW THAT 6% OF INDIVIDUALS OVER THE AGE OF 65 EXPERIENCE SOME FORM OF VISION IMPAIRMENT, AND PROJECTIONS INDICATE THAT BY 2050, THE NUMBER OF PEOPLE WITH VISION LOSS WILL DOUBLE. IN RESPONSE TO THIS GROWING CONCERN, VISIONCORPS OFFERS VITAL SERVICES TO INDIVIDUALS AT ALL STAGE OF VISION LOSS. THE IMPACT OF LOW VISION CAN VERY SIGNIFICANTLY FROM PERSON TO PERSON, AND VISIONCORPS TAILORS ITS APPROACH TO MEET EACH INDIVIDUAL'S UNIQUE NEEDS. THIS YEAR, VISIONCORPS PROVIDED COMPHREHENSIVE, INDIVIDUALIZED SERVICES TO 1,261 CLIENTS, DELIVERING A TOTAL OF 12,001 HOURS OF DIRECT SERVICES. THROUGH PERSONALIZED ASSESSMENTS, EDUCATION, SUPPORT, AND TRAINING, VISIONCORPS HELPS INDIVIDUALS REGAIN THEIR INDEPENDENCE AND MAINTAIN THEIR QUALITY OF LIFE DESPITE VISION CHALLENGES.
